Golf Cart Liability Waiver

1. Operator expressly acknowledges and agrees that operating a Golf Cart is dangerous and involves risk of serious bodily injury or death, and/or property damage.

2. Operator expressly acknowledges that he/she is a licensed driver and is familiar with the safety features of said equipment and are certain of their own ability to operate said equipment.

In consideration of being permitted to operate and ride said equipment, Operator does for themselves, their heirs, executors, administrators and assigns, hereby release and forever discharge Pleasure Island Rentals, Pleasure Island Rentals agents and employees and assigns of and from any and every claim, demand, action or right of action, of whatever kind of nature, either in law or in equity, arising from or by reason of any bodily injury or personal injuries, known or unknown, death or property damage resulting, or to result, from any accident which may occur and any activities in the operation of the equipment whether by negligence or otherwise.

Rules and Safety Information

Operator hereby agrees to the following:

1. Operator will obey all local, state and federal regulations regarding the operation of this equipment on public traffic ways, parking lots, and in public access areas.

Physical Damage Agreement

I hereby agree to provide Pleasure Island Rentals with a security deposit of \$100.00 to be secured on a pre-approved major credit card. I also agree to compensate Pleasure Island Rentals for all damages, loss or theft of or to the unit during the rental period. I understand that I am liable for damage, loss or theft of or to the unit up to the fair market value which is \$5,500.00. I authorize Pleasure Island Rentals to charge all damages exceeding \$100.00 against the open credit card amount. Damages assessed to be less than \$100.00 will be deducted from the security deposit. I understand that the damage assessment is at the sole discretion of Pleasure Island Rentals.
